### **FORMS THAT MUST BE RETURNED:**

1. Sign and return the Employee Agreement (Please read it carefully)
2. The completed W-4 form
3. The completed I-9 form (fill out section one only)
4. Two forms of unexpired identification (Refer to pg.9 of the I-9 for acceptable forms)
5. Direct Deposit Form (Optional)

### **REQUIREMENTS FOR COMPLETING YOUR TIMESHEET:**

1. Record your exact hours daily and round daily total to the nearest quarter hour.
2. Fill out the total number of hours at the end of the week and sign your name.
3. **Your supervisor must sign for the approval of your reported hours.**
4. Check appropriate box for Mail, Pickup or Direct Deposit (if enrolled).
5. Fill in the Friday "Week Ending" date and your work number on the timesheet.
6. Email or Fax your timesheet to us each Friday.

### **Helpful Reminders:**

- **Make several copies of your blank timesheet to use in future weeks.**
- **Email or Fax your timesheet to us by Friday.** Paychecks that are mailed should arrive by Thursday unless you enrolled in direct deposit or choose to pick up your check on Thursday at our office between 11:00 AM and 5:00 PM.
- **For check pick-up:** Come to 8554 Katy Freeway; Suite 326. TFS is the office building next to Home Depot and Starbucks off Voss and Katy Fwy. Parking is free.

## Employment Policy

**\*Please read this carefully, sign and return to TFS.** Direct questions to our office at (713) 932-6800.

### Employer Expectations

#### Attendance:

Report to and leave from work at the specified times required by the client company. Absenteeism and tardiness is misconduct. In the event that you will be late or absent, please notify the client company at least one (1) hour prior to normal arrival. Failure to do so may result in disciplinary action. TFS requires a written note on your time sheet recording the reason for your absence or tardiness. Absences due to medically verifiable illness, jury duty and military leave are acceptable in moderation with valid documentation.

#### Drug Policy:

Manufacture, use, sale, possession or distribution of illegal drugs or alcohol on or off company property and time is strictly prohibited. Random drug tests and/or reasonable searches for drugs may be utilized by TFS. These tests/searches are not intended as accusation of illegal drug use, but as a safeguard within the working environment. Refusal to submit to a drug test/search or a positive outcome (i.e. discovering the presence of illegal substances in an employee's system or personal property) may be cause for termination.

#### Confidential Information / Privacy:

Employees must exercise care in reference to any and all confidential information of the company they assist. This information may not be taken, copied or communicated in any way to other parties. Doing so is a third-degree felony. Any office equipment (voice mail, e-mail, computers, etc.) or work areas are for business use only and are subject to access by the client and TFS. These are not, nor may they be regarded as, private or confidential. Misuse may result in disciplinary action.

#### Disciplinary Issues:

Failure to act appropriately is considered misconduct. You are required to follow the client company's behavioral "house rules" while on assignment. Fighting, use of offensive language, illegal drug or alcohol use, mismanagement of your position, absenteeism/tardiness, harassment and violence, among other offenses, are considered disciplinary issues and will be documented. Your understanding of the issue may be submitted to TFS. Discipline may include termination.

### Employee Expectations

#### Paydays/Paychecks:

- For all weekly hourly employees, scheduled weekly paydays are every **Thursday**, with exception for those that fall on a holiday. In that event, the payday will occur on Friday. Checks are available to be picked up on **Thursday at 11 :00AM. The employee must fax in time sheets by 6PM on Friday to guarantee timely check processing.**
- *For semimonthly employees*, scheduled paydays are the TFS business day on or before the 15th and 31<sup>st</sup> of each month. Checks are available by 5:00PM dependent upon the receipt of the time sheet by 12:00PM on the payday. Please note: salaried employees are paid only through the final day of their employment should the assignment end mid-pay period.
- *All employees:* Paychecks should not be picked up by anyone other than the employee without prior written consent on file with TFS. Also, be aware that TFS is not responsible for lost/stolen/undelivered mailed checks and a \$20.00 replacement fee may be deducted from the replacement. **TFS requires waiting one week from the original mail date before reissuing a check.**

#### Tax/Employment Records:

TFS issues a W-2 at year-end for your tax records. **Make sure to notify us of your address changes to ensure that we send it to the correct address.** Also, should you wish to change your W-4 or update your employment records with new information, please call us promptly. Employee records are not released without prior written consent by the employee, excepting requests government agencies.



TFS operates on a 40-hour workweek. Time worked in excess of 40 hours will be paid at time and one-half. **Employees must discuss the possibility of overtime hours with their immediate supervisor to avoid working in excess of the client's needs. Regardless, the time sheet must reflect actual hours worked.** Bonuses, severance pay, parking/toll reimbursements, vacation pay, sick leave and pay for time not worked is not paid by TFS, with exception for instances in which the client company, at its option, wishes to have the employee paid. Voluntary deductions will not be made from paychecks without prior authorization from the employee; however paychecks may be adjusted to reflect actual hours worked in the event of time sheet error or miscalculation.

Benefits:

TFS does not offer group insurance, pension plans, paid holidays/vacations or other benefits to temporary/contract employees. Workers compensation coverage is maintained.

Safety/Reporting Injuries:

It is the responsibility of the employee to familiarize himself with the safety and emergency procedures of the client company. Should an employee suffer an injury, he/she must inform both the client and TFS the day of the injury so that proper attention may be given and documentation recorded. Quick notice is important to assure accurate information in the event of a claim.

Discrimination:

TFS is an Equal Opportunity Employer and complies with all state and federal laws regarding discrimination. Inform TFS of any instance in which you are subject to discrimination.

Sexual Harassment:

Inform TFS promptly should you be harassed or accused of harassment on the job. Harassment is defined by the Equal Opportunity Commission as "unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature when submission to the conduct enters into employment decisions and/or the conduct unreasonably interferes with an individual's work performance or creates an intimidating, hostile, or offensive working environment."

**Administrative Issues**

This Policy:

This employment policy is a guideline and is not intended to imply any contractual rights. It may be changed or modified by TFS at any time without advance notice to employees.

Employment Termination:

This policy is not intended to construe a guarantee of continued employment. Employment is "at-will", meaning that either the employer (TFS) or the employee may terminate employment at will (at any time). Termination may occur for any or no reason. **TFS requires you to call (713) 932-6800 and advise of your last day on the assignment and your availability for further work on or before the first business day after your assignment ends.** (This is separate from any requirements your personnel consultant may have.) Failure to do so may negatively affect your employment status and relinquish your entitlement to pursue unemployment benefits.

### Employee Acknowledgment of Workers' Compensation Network

I have received information that informs me how to get health care under my employer's workers' compensation insurance.

If I am hurt on the job and live in a service area described in this packet, I understand that:

- I must choose a treating doctor from the list of doctors in the network. Or, I may ask my HMO primary care physician to agree to serve as my treating doctor. If I select my HMO primary care physician as my treating doctor, I will call Texas Mutual Insurance Company at (844) 867-2338 to notify them of my choice.
- I must go to my treating doctor for all health care for my injury. If I need a specialist, my treating doctor will refer me to a specialist. If I need emergency care, I may go anywhere.
- Texas Mutual will pay the treating doctor and other network providers for the treatment for my compensable injury.
- I may have to pay the bill if I get health care from someone other than a network doctor without prior network approval.

Knowingly making a false workers' compensation claim may lead to a criminal investigation that could result in criminal penalties such as fines and imprisonment.

## General Instructions

### Future Developments

For the latest information about developments related to Form W-4, such as legislation enacted after it was published, go to [www.irs.gov/FormW4](http://www.irs.gov/FormW4).

### Purpose of Form

Complete Form W-4 so that your employer can withhold the correct federal income tax from your pay. If too little is withheld, you will generally owe tax when you file your tax return and may owe a penalty. If too much is withheld, you will generally be due a refund. Complete a new Form W-4 when changes to your personal or financial situation would change the entries on the form. For more information on withholding and when you must furnish a new Form W-4, see Pub. 505.

**Exemption from withholding.** You may claim exemption from withholding for 2020 if you meet both of the following conditions: you had no federal income tax liability in 2019 and you expect to have no federal income tax liability in 2020. You had no federal income tax liability in 2019 if (1) your total tax on line 16 on your 2019 Form 1040 or 1040-SR is zero (or less than the sum of lines 18a, 18b, and 18c), or (2) you were not required to file a return because your income was below the filing threshold for your correct filing status. If you claim exemption, you will have no income tax withheld from your paycheck and may owe taxes and penalties when you file your 2020 tax return. To claim exemption from withholding, certify that you meet both of the conditions above by writing "Exempt" on Form W-4 in the space below Step 4(c). Then, complete Steps 1(a), 1(b), and 5. Do not complete any other steps. You will need to submit a new Form W-4 by February 16, 2021.

**Your privacy.** If you prefer to limit information provided in Steps 2 through 4, use the online estimator, which will also increase accuracy.

As an alternative to the estimator: if you have concerns with Step 2(c), you may choose Step 2(b); if you have concerns with Step 4(a), you may enter an additional amount you want withheld per pay period in Step 4(c). If this is the only job in your household, you may instead check the box in Step 2(c), which will increase your withholding and significantly reduce your paycheck (often by thousands of dollars over the year).

**When to use the estimator.** Consider using the estimator at [www.irs.gov/W4App](http://www.irs.gov/W4App) if you:

1. Expect to work only part of the year;
2. Have dividend or capital gain income, or are subject to additional taxes, such as the additional Medicare tax;
3. Have self-employment income (see below); or
4. Prefer the most accurate withholding for multiple job situations.

**Self-employment.** Generally, you will owe both income and self-employment taxes on any self-employment income you receive separate from the wages you receive as an employee. If you want to pay these taxes through withholding from your wages, use the estimator at [www.irs.gov/W4App](http://www.irs.gov/W4App) to figure the amount to have withheld.

**Nonresident alien.** If you're a nonresident alien, see Notice 1392, Supplemental Form W-4 Instructions for Nonresident Aliens, before completing this form.

## Specific Instructions

**Step 1(c).** Check your anticipated filing status. This will determine the standard deduction and tax rates used to compute your withholding.

**Step 2.** Use this step if you (1) have more than one job at the same time, or (2) are married filing jointly and you and your spouse both work.

Option (a) most accurately calculates the additional tax you need to have withheld, while option (b) does so with a little less accuracy.

If you (and your spouse) have a total of only two jobs, you may instead check the box in option (c). The box must also be checked on the Form W-4 for the other job. If the box is checked, the standard deduction and tax brackets will be cut in half for each job to calculate withholding. This option is roughly accurate for jobs with similar pay; otherwise, more tax than necessary may be withheld, and this extra amount will be larger the greater the difference in pay is between the two jobs.



**Multiple jobs.** Complete Steps 3 through 4(b) on only one Form W-4. Withholding will be most accurate if you do this on the Form W-4 for the highest paying job.

**Step 3.** Step 3 of Form W-4 provides instructions for determining the amount of the child tax credit and the credit for other dependents that you may be able to claim when you file your tax return. To qualify for the child tax credit, the child must be under age 17 as of December 31, must be your dependent who generally lives with you for more than half the year, and must have the required social security number. You may be able to claim a credit for other dependents for whom a child tax credit can't be claimed, such as an older child or a qualifying relative. For additional eligibility requirements for these credits, see Pub. 972, Child Tax Credit and Credit for Other Dependents. You can also include **other tax credits** in this step, such as education tax credits and the foreign tax credit. To do so, add an estimate of the amount for the year to your credits for dependents and enter the total amount in Step 3. Including these credits will increase your paycheck and reduce the amount of any refund you may receive when you file your tax return.

### Step 4 (optional).

**Step 4(a).** Enter in this step the total of your other estimated income for the year, if any. You shouldn't include income from any jobs or self-employment. If you complete Step 4(a), you likely won't have to make estimated tax payments for that income. If you prefer to pay estimated tax rather than having tax on other income withheld from your paycheck, see Form 1040-ES, Estimated Tax for Individuals.

**Step 4(b).** Enter in this step the amount from the Deductions Worksheet, line 5, if you expect to claim deductions other than the basic standard deduction on your 2020 tax return and want to reduce your withholding to account for these deductions. This includes both itemized deductions and other deductions such as for student loan interest and IRAs.

**Step 4(c).** Enter in this step any additional tax you want withheld from your pay **each pay period**, including any amounts from the Multiple Jobs Worksheet, line 4. Entering an amount here will reduce your paycheck and will either increase your refund or reduce any amount of tax that you owe.



Step 2(b) – Multiple Jobs Worksheet (Keep for your records.)



If you choose the option in Step 2(b) on Form W-4, complete this worksheet (which calculates the total extra tax for all jobs) on only ONE Form W-4. Withholding will be most accurate if you complete the worksheet and enter the result on the Form W-4 for the highest paying job.

Note: If more than one job has annual wages of more than \$120,000 or there are more than three jobs, see Pub. 505 for additional tables; or, you can use the online withholding estimator at www.irs.gov/W4App.

Generally, tax returns and return information are confidential, as required by Code section 6103.
